What is an adult day service and who may it be suitable for?

Adult day services are HSE funded programmes to provide day service supports to people, age 18 and over, with intellectual disabilities, autism, or people with complex physical disabilities. The programmes assist people to make choices and plans and to be an active, independent member of the community. Service Providers have individual service entry criteria and deliver varying degrees of supports to people with a very disperse set of needs, wishes and aspirations

The HSE fund **NEW DIRECTIONS** type day services. New Directions provides a Model of Supports organised around the person, based on their identified needs and wishes. This approach sets out to ensure that being part of one's community is a real option. To read more about New Directions go to HSE's website: www.hse.ie/newdirections

Rehabilitative training programmes are training courses funded by the HSE to develop life skills, social skills, and basic work skills for people with intellectual disabilities, autism, mental health difficulty or people with complex physical disabilities. The courses usually last from two to four years. These courses can be a stepping stone to more mainstream education or training options. (Mental Health programmes are only available in some areas)

Referral Criteria

- To refer for HSE Day Service the student must have a confirmed diagnoses completed of any of the following areas:
 Autism Spectrum Disorder (ASD), Mild Moderate or Severe Intellectual Disability, Physical and Sensory impairment (deaf / hard of hearing or blind/visually impaired)
- Diagnoses <u>NOT</u> meeting this criteria are: ADHD, Mental health issues only, such as Depression, Anxiety, or Dyslexia, Dyspraxia, Dyscalculia
- If the young person is planning on going on to third level education then there is no requirement for a referral to a day service.

Adult Disability Day Services Transition Pathway:

Step 1

- Identification of all prospective young people transitioning to Adult Disability Services.
- Childrens Disability Network Team to forward list for each area to Adult Day Disability Services by mid-May, year prior to young person leaving school/turning 18
- Childrens Disability Network Team to access list of school leavers on IMS as per IFSP goals

Step 2

The Adult Disability Day Services office will notify the Childrens Disability Network
Team of young people whom they have not received a referral form for end May year
prior to young person leaving school/turning 18

Step 3

- If no referral has been made by school, the lead clinician to make initial contact with young person and parent to determine if they would like to be considered for a day service (Ensure criteria has been met as outlined on page 2)
- Send letter and leaflet explaining "What is a Day Service " and consent form (Appendix 1,2, 3 and 6) to the young person. On receipt of consent form the lead clinician should complete the referral form (Appendix 5) and forward with the signed consent form to disabilitydayservices.cho5@hse.ie
- June of year prior to the young person leaving school.

Step 4

• The Day Opportunities Officer will then make contact with the young person and arrange to meet with them to go through day service options and complete profile assessment if necessary. August to December 2024

Step 5


- Jan/Feb face to face meeting with Childrens Disability Network Team, and local Day Opportunities Officer to discuss all school leavers for the current year and identify any key requirements. Adult Disability Case Manager may also participate in this meeting.
- For complex cases, a case review may be required between the relevant clinicians in the Childrens Disability Network Team, the Day opportunities Officer, members of adult disability team and any other relevant professions including school if required.

Step 6

- Lead clinician with the assistance relevant members of Childrens Disability Network
 Team to complete transition form and provide any relevant reports to advise local Day
 Opportunities Officer if any specific supports, equipment or considerations that will be
 required to support the person in their day service. Appendix 6 and forward to relevant
 Day Opportunities Officer for the area.
- Childrens Disability Network Team clinicians to update the young person's IMS file for transition to adult day services
- Jan to April of the year the young person is leaving school/turning 18.

Step 7

- Lead clinician to inform administration regarding the outcome of the adult day service transition process. Young person will be discharged from Childrens Disability Network Team once they turn 18yrs old
- Day Opportunities Officer to ensure that all relevant reports/assessments from Childrens Disability Network Team are forwarded to service providers where relevant once identified for each young person by end of July young person is leaving school/turning 18







